The mission of **Jewish Silicon Valley** is to “harness the power of community to improve lives, build bridges of understanding, and strengthen the Jewish people here, in Israel, and around the world.” Jewish Silicon Valley is committed to providing our Jewish partner agencies and community with the funding that will have the most impact in supporting the well-being, strength, and future of our community.

In response to the Hamas attack against Israel on October 7, Jewish Silicon Valley launched the **Israel Emergency Campaign** to help our local community cope with the impact of the war. The goal of this fund is to help our community cover some of the unexpected local losses resulting from this unprecedented crisis in Israel. This fund is possible through the generosity of Chai House Inc. and dozens of individual donors.

**We have currently allocated out all available funds. We are assessing what funds may become available for the next quarter. Please feel free to submit your request for financial assistance in the meantime and we will let you know your status as soon as possible.**

Our staff will be using the guidelines below for reviewing requests and allocating funds:

- There are three grant categories to choose from: *Security, Community Gatherings, and Community Support Services.*
- An organization is allowed to apply for multiple grants and each request will be considered separately.
- This fund is NOT to be used to cover revenue shortfalls, and is intended to only cover additional, unplanned, temporary costs related to the aftermath of the October 7 attack on Israel. Funding for permanent solutions/associated costs will not be granted.
- Only requests with invoices dated April 1 through June 30, 2024 will be considered for this funding cycle.
- Currently, there is no minimum or maximum request amount allowed. Grant decisions are made based on funds available at the time of submittal and the needs of the community.
- Scholarships will be considered on a case-by-case basis and are intended to cover any added costs of families displaced from Israel.
- JSV has permission to use the grantee's name and logo, as well as any other information or materials provided by the grantee, in any press releases and/or publications related to this grant without further notice to the grantee.
- The grantee may use JSV's name in any press releases or publications solely to recognize JSV as a supporter of the grantee.

### Applicant Requirements

- Must have 501c3 tax status
- Must have a mission that is aligned with the mission of Jewish Silicon Valley
- Must be willing to submit organizational budget if requested.
